The very first bill **Governor Sununu** ever signed into law allows dangerous individuals to legally carry hidden, loaded weapons. **Senators Jim Gray** (R-Rochester), **John Reagan** (R-Deerfield), and **Jeb Bradley** (R-Wolfeboro) all sponsored this measure, as well as refused to ban dangerous bump stocks or support gun free school zones.
