BASIS OF COMPLAINT

The Candidate Committee Friends of Chris Sununu has accepted nearly \$20,000 in unlawful contributions from partnerships. New Hampshire law squarely prohibits contributions by partnerships. See, RSA 664:4, II. Partnership is defined under New Hampshire law in RSA 304-A:6 to include limited liability partnerships (LLPs) (“Partnership Defined. - A partnership is an association of 2 or more persons to carry on as co-owners a business for profit and includes, for all purposes of the laws of this state, a registered limited liability partnership.” (emphasis added)). The Candidate Committee “Friends of Chris Sununu”, on three separate occasions, accepted campaign contributions from partnerships, in violation of RSA 664:4, II. To wit: 1. \$7,000 from Gexa Energy, LP made on January 24, 2017; 2. \$4,250 from Nixon Peabody LLP of Boston, MA made on May 8, 2017; 3. \$7,000 from Keegan Werlin LLP on September 15 2017.

A search of Florida corporation filings did not reveal an entity called Gexa Energy registered as a corporation, LLC, LP, trademark, fictitious name, general partnership or LLP, and no entities of that name registered at 700 Universe Boulevard. However, Gexa Energy, LP of 700 Universe Blvd., Juno Beach, FL is registered in Texas and has a taxpayer ID of 14216749235.

Gexa Energy, LP shows two owners on its most recent filing with the Texas Secretary of State. Gexa Energy GP, LLC is listed as the general partner, and Nextera Energy Services, LLC as an additional owner with 99% ownership (partners with less than a 10% stake aren't listed). Gexa Energy GP, LLC lists only Nextera Energy Services Holdings, LLC as the sole owner. Nextera Energy Services Holdings, LLC is registered in Delaware. Filings attached.
